# Morrisville Fire Station No. 1 Solar Panel Array

## **Project Set for Summer 2021**

The Town of Morrisville is moving forward with its first permanent renewable energy project, the installation of a 30kW solar panel array on Morrisville Fire Station No. 1 on Town Hall Drive. Once completed, the array will generate approximately 40 percent of the station's electricity usage and reduce Town emissions by 22 metric tons. The array will be integrated with the Smart Morrisville initiative, and will include a networked dashboard monitor for Town staff and residents to see the array's energy production in real-time. Southern Energy Management, a Certified B Corporation, will start the installation of the array over the next few months. The array is slated for completion over the course of 2021. The Town will provide periodic updates to the public through the Town's website and other communication channels. To learn more about Southern Energy Management visit www.southern-energy.com. This position was designed to help develop a platform to support sustainable clean energy, environmental stewardship, and community engagement in Morrisville. Before joining the Town, I was a clean energy industry project manager for NC State University, working on a myriad of industry and local government projects. My desire to engage in impactful and rewarding work in sustainability was inspired by my coursework while earning my master's of arts in liberal studies degree.

# What does the Morrisville Fire Department No. 1 Solar Panel Array represent?

Adding a renewable energy system is one of the best ways to demonstrate the Town's commitment to sustainability because it directly offsets or replaces electricity generated and provided by our utility, Duke Energy. Solar is a powerful visual for progressive, future-thinking renewable energy technology that offsets Morrisville's environmental impact.

The dashboard monitor for the solar panel array will be another example of transparency and accountability through our Smart Cities initiative. The dashboard provides a way to engage with our residents and demonstrate, in real-time, what our solar array is producing or conversely, what it's saving in emissions; the equivalent of trees planted or maybe even something specific such as fire trucks charged or first responders' oxygen tanks refilled as a portion of the electricity we harness from the sun.

#### How can Morrisville residents be involved in and support Morrisville's sustainability platform and initiatives?

On an individual level, we can be mindful of the decisions we make daily. Those decisions include proper recycling, minimizing food waste, walking or biking, considering solar for your home, or buying an electric car. Additional opportunities include supporting the local vendors at the Western Wake Farmer's Market, volunteering in the Community Garden, and taking part in the Morrisville Stewardship Program.

# How does your role managing the sustainability efforts integrate Smart Morrisville and Smart City initiatives? How do these areas complement the Town's strategic plan and goals to serve residents?

The Town's Open Data Portal provides an opportunity to engage and learn about how we're striving as a community to create a smarter and more sustainable Morrisville every day. The sustainability-focused projects will largely live under the "Environmental" tab being built, allowing residents to see insightful and actionable information.

As an example, we plan on showing information on our electric vehicle (EV) charging stations so that EV owners can make decisions on where to charge based on their travel plans.

Another example is the addition of sensors at Cedar Fork District Park, which has a history of flooding. Park sensors will feed data to a portal that residents can check before visiting the park. Those same sensors will automatically close the park gates so that a Public Works employee doesn't have to jump in a truck (generating emissions) to close the gate.

# Morrisville Upgrades to Hybrid Police SUVs

In 2020 Morrisville's Fleet Division converted their police vehicle purchasing plan from gasoline powered vehicles to pursuit-rated hybrid police SUVs.

The conversion started in the summer of 2020 with the purchase of Ford Police Interceptor SUVs that are a combination of gas engines and on-board electrical motors powered by lithium-ion hybrid batteries. Each SUV has factory default law enforcement specific options. The Town further upfits them to fit our local needs. Once they arrive from the factory, the Town installs all the lights, radios, radars, computers, cameras, and markings in the vehicles prior to their use. To date, the Town has nine Ford Police Interceptor Hybrid SUVs in the Fleet Division.

The advantage of a hybrid vehicle over a standard vehicle comes from the savings while idling. Police vehicles sit idle for long periods of time. The hybrids use battery power to reduce the engine running time, saving both fuel and emissions. Based on information from Ford's Hybrid SUV savings calculator, the advantages of using hybrids versus nonhybrids in the fleet include the following annual savings and reductions per vehicle:

- 500 gallons of fuel at a cost savings of \$1,200
- Potential reduction of 9,775 pounds of CO<sub>2</sub>

The Town will continue working toward reducing our carbon footprint by exploring new technologies in our fleet.

The Connect Morrisville Strategic Plan was adopted in April of 2018 with considerable accomplishments being made to date. A strategic plan update is needed to see what areas can potentially be streamlined, expanded, and clarified to make it germane to staff and the Morrisville community alike.

Morrisville Public Works conducts white goods collection every three months.

# **Policy Updates**

At its November 10 and 24 meetings, Town Council reviewed and subsequently approved several amendments to the Appointed Public Bodies Administrative Policy, which is the guiding document for all Morrisville advisory committees.

The policy was comprehensively reviewed by staff and any outdated references were removed and unclear areas were addressed. Sections were reworded and realigned to add proper context. The authority, roles, and responsibilities of the Town Council, Town staff, and Committee members were clarified. The full updated policy is available on the Town's website for quick reference, with the final document pages denoting high-level changes made in each version. Additional language was incorporated into the policy to further enhance collaboration between Town Council and advisory committees and clarify each's roles and responsibilities.

#### Updates include:

- A provision for Town Council review of advisory committee charters at least once every two years
- Expanded guidelines for the establishment and use of subcommittees by advisory committees
- Provisions for development of annual work plans, twice-yearly reports to Town Council, and an annual meeting with Town Council
- Transition responsibility for Town Council to approve of selection of Chair and Vice-Chair
- Advisory committees providing recommendations to Town Council

As noted within the policy, the Town Clerk offers orientation for all advisory committee members and supporting department staff each spring. For details on this training email the Town Clerk at townclerk@townofmorrisville.org.

# **2020 CAFR**

The Town of Morrisville's Finance Department recently published the Comprehensive Annual Financial Report (CAFR) for 2020, the official statement of the Town's financial position as of the end of the fiscal year, June 30, 2020.

The Financial statements and supplementary schedules in the CAFR were audited by Cherry Bekaert LLP, Certified Public Accountants.

#### A few CAFR Highlights Include:

- The Town's Finance Department received its 26th Consecutive Annual Certificate of Achievement for Excellence in Financial Reporting by the Government Finance Officers Association of the United States and Canada (GFOA).
- As of the end of this fiscal year, the Town of Morrisville maintained its AAA bond rating - the best possible rating for a local government - with Standards and Poor's and Fitch and its Aaa rating by Moody's.
- The Town's assets and deferred outflows exceeded its liabilities and deferred inflows of resources at the close of the fiscal year by \$182,600,191 (net position). Of this amount, \$10,819,174 (unrestricted net position) may be used to meet the Town's ongoing obligations to citizens and creditors.
- The Town's total outstanding debt decreased by \$2,427,841 in the current fiscal year due to payments on outstanding debt. The Town issued no new debt in fiscal year 2020.
- The Town's total net position increased by \$4,743,807 in fiscal year 2020 of which \$5,423,509 was derived from an increase in governmental activities and decrease in business type activities of \$679,702 in fiscal year 2020.
- As of the close of the 2020 fiscal year, the Town of Morrisville's governmental funds reported a combined ending fund balance of \$53,180,558, a decrease of \$5,261,390 over the prior year, 2019. Approximately 29.65% of total governmental funds fund balance, or \$15,765,786 is available for spending at the Town's discretion (Unassigned fund balance).

The Bond Portal closed on January 31 receiving great input. A summary report will be provided to Council in February. Your feedback provides Council with important community insight as they deliberate on how best to invest tax-supported dollars that help shape future capital projects that can make a difference for our growing community. Council and staff are working to identify and align potential bond project packages to formulate appropriate ballot questions.

The November 2021 election ballot will ask voters, using separate ballot questions when developed, whether taxpayers approve of the Town's use of general obligation (GO) bonds to finance future capital projects. 
